
Specialty Pharmacy Network for SCEMBLIX

Options to Fill a SCEMBLIX Prescription

The Specialty Pharmacy Network for SCEMBLIX was designed to provide options to meet the different needs of accounts, health care providers, and patients. Health care providers will be able to choose where to send a SCEMBLIX prescription for fulfillment:

- Either 1 of the 2 network specialty pharmacies (Biologics or Onco360®) OR
- An in-office dispensing pharmacy or a health system pharmacy

When ready to prescribe SCEMBLIX, inform the patient which specialty pharmacy will dispense the prescription, and that they will be contacted by phone to arrange delivery. The HCP or office staff can call the network Specialty Pharmacy for questions or assistance.

Features of the Specialty Pharmacy Network

- For providers/practices: Streamlined communication through fewer specialty pharmacy contacts and consistency of processes in accessing SCEMBLIX for your patients
- For SCEMBLIX patients: Coordination with HCP office, consistent education on the critical phases of prescription initiation, the early phases of treatment, and on-going communication and support throughout the treatment journey



Aiding Patient Access to SCEMBLIX

The network specialty pharmacies will coordinate with non-network pharmacies to transition existing patients and maintain continuity of medication for patients.

- Existing patients: In most cases, the network specialty pharmacies will handle transfer of the patient's prescription and fill subsequent scripts. Once the transfer is complete, the network pharmacy will contact the patient to coordinate delivery of SCEMBLIX. There will be no change for patients already filling prescriptions through Biologics, Onco360®, in-office dispensing pharmacies, or health system pharmacies
- New patients: Providers may send the SCEMBLIX prescription to one of the network specialty pharmacies or to their in-office pharmacy/health system pharmacy. Sites currently dispensing SCEMBLIX can continue to order through their existing specialty distributor
